#### I. CALL TO ORDER

Chairman Laura Pitone called a Regular Meeting of the School Committee to order in the aldermanic chambers at 7:06 p.m., with a moment of silence and a salute to the flag of the United States of America. Ms. Pitone asked for a roll call, the results of which are as follows: - Present - 7 - Futrell, Palmer, Roix, Normand, White, Green and Pitone and Absent - 2 - Curtatone and O'Sullivan.

#### II. STUDENT ADVISORY COUNCIL

Student Representative, Dessources Domond was not in attendance this evening.

The following next items will be taken out of order so that presenters, etc. can get their business finished and leave.

**<u>Field Trips</u>**: (recommended action: approval)

April 19-27, 2018 Somerville High School students to Costa Rica. Transportation via plane, etc. Cost to students is \$2,300. Each.

High School staff Alicia Kersten (Dept. Head for Social Studies) and Marianna Hosking (Dept. Head for Science) were in attendance to speak about the field trip and to answer any questions from members.

MOTION: Mr. Roix made a motion, seconded by Ms. Normand, to approve the field trip to Costa Rica. The motion was approved via voice vote.

#### IV. REPORT OF SUPERINTENDENT

#### A. District Report

• Recognition of Somerville High School students for their S.A.F.E.T.Y. proposal

Somerville High School student, Katia Mathews was introduced and presented information to the School Committee on the student-initiated S.A.F.E.T.Y. (Safely Accommodating Free Equity for Tampons Yearly) program at the school. The PowerPoint slides are included at the end of these minutes. The presentation included a short video and information on the following:

- The mission of the initiative which is to provide free female feminine hygiene products, promote gender equity, help low-income students who otherwise may not be able to afford the products and create comfort for all students.
- Steps taken to facilitate the initiative
- Next steps

Following the presentation, members and those in the audience, applauded this young woman on such a wonderful job as well as for the leadership and thoughtfulness that she and the other two young ladies put into this project. The three students were praised for their maturity and leadership.

Superintendent Skipper reported on the impact of students opting-out of participating in MCAS testing on the District and the discussion that ensued which included the following:

- The District uses a balanced approach to standardized testing.
- Moratorium on testing resolution
- The use of data to improve learning, especially where there are gaps, is very valuable
- It was helpful to receive the letters and suggestions for a process for opting out
- The procedure should not be made school by school. It should be district informed.
- Mrs. Skipper and Dr. McKay applaud the School Committee for their directive to the district regarding information for parents who wish to opt out.
- Dr. McKay added that this is a balancing act where we are meeting the legal state requirement while trying to respect parents and students. This is a great lesson for kids regarding public policy and making things work.
- Guidance has been drafted with input from the Department of Ed's Chief MCAS Officer and our legal counsel.
- We have to meet our obligations and provide a comfort level for people with concerns
- Participation rate requirement for tests of 90% for the current school year.
- Our accountability level could be impacted without the majority of parents having a say
- Administration believes in consistent messaging
- The District value to this test
- Discussion of actions by the MCIEA regarding assessment what, who, how often?
- The amount of time on prepping for the test

#### Consideration of policy or resolution regarding MCAS Opt Out

Ms. Palmer presented the following draft policy regarding students opting out of testing:

MOTION: Ms. Palmer made a motion, seconded by Mr. Green, to approve the following policy:

The Somerville School Committee recognizes that some parents and students may opt not to take part in the MCAS state testing program. As suggested by Education Commissioner Mitchell Chester in his Jan. 29, 2016 memorandum to school officials, students "should not be pressured to take the test, nor should they be punished for not taking the test. They may sit quietly and read in the testing room."

Therefore, if the school principal is notified by letter or in person by the child's parent(s)/guardian(s), prior to the first test for that grade, that child will not be asked to take the test, be signed into the test, be asked to sign into the test, given the test in paper form, nor sat at a computer on which the test is administered for any of the testing sessions.

Unless otherwise specified by parent(s)/guardian(s), it is assumed that a child who has opted out is refusing to take all of the MCAS tests for the entire academic year. Notification must be resubmitted for each new academic year. Any child who is not being tested may remain in the room with the children being tested (unless an alternate location can be agreed upon) and may read quietly or be given another suitable activity as the principal determines."

Discussion ensued which included the following:

- More conversation is needed on this topic as some members are just seeing/hearing about it for the first time
- Many people are unaware of this issue
- The need for consistent, well-publicized procedures
- Policy needs to be in line with federal and state guidelines

A decision was made to forward this matter to the rules Management Committee of the Whole, which will be held on May 1 at 6:00 p.m. and well publicized.

The School Committee took a recess at 9:02 p.m.

The meeting resumed at 9:14 p.m.

Ms. Palmer departed the meeting at 9:16 p.m.

#### V. NEW BUSINESS

#### A. Contract of the Assistant Superintendent of Schools

Mrs. Skipper announced that, with Dr. McKay sailing of into retirement, a search was done to find his replacement. Lots of input was taken through focus groups, etc. and there were in excess of 85 resumes for the position. 11 people were interviewed and three finalists were forwarded for interviews by the Superintendent. These three people were interviewed and spent time with cabinet members and also went on a tour of one of our schools. After this process was completed and reference checks were made, the unanimous choice of both the interview team and the Superintendent and her cabinet team was Dr. Almudena Abeyta. Dr. Abeyta comes to us with a great amount of experience and is currently doing a similar job in Santa Fe, New Mexico.

Ms. Pitone now asked for a member to make a motion to approve Dr. Abeyta's contract.

MOTION: Mr. Roix made a motion, seconded by President White, to approve the contract of employment between Dr. Almudena G. Abeyta and the Somerville School District for the position of Assistant Superintendent of Curriculum, Instruction and Assessment. The term of this contract shall commence on July 1, 2017 and end on June 30, 2010, consistent with the provisions of G.L. c. 71§§41 and 59. The motion was unanimously approved via voice vote.

Prior to adjourning, Mr. Green expressed the School Committee's condolences for the passing of staff and family members of staff who have recently passed.


