ORDER OF BUSINESS

I. CALL TO ORDER

Chairman Carrie Normand called a Regular Meeting of the School Committee to order in the Board of Aldermen's Chambers at City Hall at 7:05 p.m., with a moment of silence and a salute to the flag of the United States of America. Ms. Normand asked for a roll call, the results of which are as follows: - Present -7 – Palmer, White, Roix, Futrell, Green, Bockelman and Normand and ABSENT -2 – Curtatone and Pitone.

II. STUDENT ADVISORY COUNCIL – Mr. Ojo was absent this evening.

III. NEW BUSINESS

A. MSBA Statement of Interest

Ms. Normand announced that we would be taking Item V. A – Massachusetts School Building Authority (MSBA) Statement of Interest for the Winter Hill Community School, out of order. Rob King from Capital Projects was in attendance to answer any questions members may have had. At this time, we are seeking consideration regarding the repair/replacement of the roof and windows at the Winter Hill Community Schools. Approval of this Statement of Interest in no way obliges us; this is merely a way of letting the MSBA know that we have an interest in having this project considered. Filing of this paperwork merely adds us to the list of projects up for consideration by the MSBA.

MOTION: Mr. Green made a motion, seconded by Mr. Bockleman, as follows:

Resolved: Having convened in an open meeting on February 1, 2016, prior to the closing date, the School Committee of the City of Somerville, in accordance with its charter, by-laws, and ordinances, has voted to authorize the Superintendent to submit to the Massachusetts School Building Authority the Statement of Interest Form dated Friday, February 12, 2016 for the Winter Hill School located at 115 Sycamore Street, Somerville, MA 02145 which describes and explains the following deficiencies and the priority category(s) for which an application may be submitted to the Massachusetts School Building Authority in the future: Category 5 - Replacement, renovation or modernization of school facility systems, such as roofs, windows, boilers, heating and ventilation systems, to increase energy conservation and decrease energy related costs in a school facility (specifically roof and window replacement for this project) and hereby further specifically acknowledges that by submitting this Statement of Interest Form, the Massachusetts School Building Authority in no way guarantees the acceptance or the approval of an application, the awarding of a grant or any other funding commitment from the Massachusetts School Building Authority, or commits the City of Somerville to filing an application for funding with the Massachusetts School Building Authority.

The motion was approved via unanimous voice vote.

IV. REPORT OF SUPERINTENDENT

A. District Report

Mrs. Skipper provided her district report as follows:

• Our District central offices have moved across the street to the Edgerly Education building at 8 Bonair Street while some work is completed at the 42 Cross Street building. Once the work at 42 Cross has been completed, the Superintendent's, Curriculum, Student Services, and Communications offices will remain at the Edgerly, and the Finance, Payroll, and Human Resources offices will relocate back to 42 Cross. Additional district curriculum staff members will also be moving to the Edgerly at that time. We will continue to keep you updated on district office changes as they occur. A lot of people have been instrumental in ensuring a smooth transition, but I want to especially acknowledge Pat Durette for her outstanding work in coordinating the move, our Technology Department for ensuring very

minimal technology down time during the transition, DPW for their work in preparing the Edgerly facility, and Capital Projects for their continuing work on 42 Cross Street. **UPCOMING EVENTS:**

Representatives from City Hall, the Somerville Public Schools, Somerville Police and Fire and the community will affirm the message that Somerville is a Sanctuary City where City officials stand by the immigrant community. The meeting will take place from 9:30-11:30 in the Alderman's Chambers at City Hall.

٧. **UNFINISHED BUSINESS**

A. 2016-2017 School Calendar

Mrs. Skipper highlighted changes made to the calendar being presented this evening that differ from the calendar members reviewed last week. These changes were - removing the early release day in November (there was an extra early release day on the previous version) and designating the 180th day of school as a ½ day for all students. Mrs. Skipper also reported her verification that principals wish to keep Election Day as a no school day due to safety and disruption concerns. Also, the Friday prior to Labor Day is a no school day in accordance with language in the STA, Unit A, Collective Bargaining Agreement.

B. Somerville Public Schools Policy Manual

File: EBC Emergency Plans

The latest version of the policy, dates 2/1/2016 is at members' seats this evening. This version has removed the reference to the opt-out clause under Chapter 71, section 1 of Mass General Law. The School Committee is still entitled to opt out, but reference to the law did not need to be included in the policy. This issue was brought to our attention last week by Alderman White.

MOTION: Mr. Roix made a motion, seconded by Mr. Green, to approve File EBC – Emergency Plans, as amended, for inclusion in the Somerville Public Schools Policy Manual.
