Chairman Adam Sweeting called a Regular Meeting of the School Committee to order in the Board of Aldermen's Chambers at City Hall at 7:00 p.m., with a moment of silence and a salute to the flag of the United States of America. Mr. Sweeting asked for a roll call, the results of which are as follows: - Present – 7 –Sweeting, Roix, Rafal, Pitone, Normand, Bockelman, and Futrell, and ABSENT – 2 – White and Curtatone.

II. APPROVAL OF MINUTES

February 23, 2015 Regular Meeting minutes

MOTION: Ms. Rafal made a motion, seconded by Mr. Futrell, to approve the minutes. The motion was approved via voice vote.

Mr. Sweeting announced that this report would be tabled until the meeting of March 16.

A. District Report

- SPED Focus Group for P/Gs Tuesday, March 3rd, 4:15pm, SHS Highlander Café. The District hired Public Consulting Group (PCG) to complete an in-depth study of Somerville's Special Education Department. PCG will be conducting a number of interviews and focus groups as part of the review process.
- A visiting team from the Massachusetts Department of Elementary and Secondary Education
 will be in the District next week conducting an audit of our English Language Learner, Special
 Education and Career and Technical Education Programs. The Coordinated Program Review
 is conducted every five years and is an assessment of how well we meet our obligations it
 is about compliance, not assessment. This audit reviews programs funded by federal funds
 and evaluates specific components.

Alderman White arrived at 7:10 p.m.

We are preparing staff this week and the preliminary oral report regarding the engagement piece of the audit should be very positive.

The Superintendent deferred to Assistant Superintendent Vincent McKay for his report on curriculum-related matters. Dr. McKay's report included the following:

- This Friday, Dr. McKay will join students from various schools at Groundworks Somerville's Maple Sap Boil down. This is held at the Community Growing Center on Vinal Ave.
- Thanks to the efforts of Mr. Bockelman, the District will host Educational Ministry officials from the Netherlands next week.

The Superintendent deferred to Finance Director Patricia Durette for a guick report on financial matters. Ms. Durette's report included the following:

٧. **UNFINISHED BUSINESS**

A. **School Calendars**

2014-2015

To recap the reasons for the calendar discussion, Mr. Pierantozzi provided the following information:

- Scheduling issue due to historical amount of snow and nine days closed due to weatherrelated issues.
- 180 day mandate by the State Department of Education
- We are one (1) day short or meeting the 180 day requirement
- Some possibilities for makeup dates are April 3 (Good Friday) and all or part of April vacation week
- In this week's packet is a large amount of information to, hopefully, guide the decision. The packet includes Contract language as scheduling makeup days on a previous holiday or vacation is a mandatory subject of collective bargaining, historical attendance data for the last weeks of school, School calendar history, MASS/MASC survey of districts, Survey results

The Superintendent's recommendation:

To authorize the Superintendent to enter into negotiations with the Somerville Teachers Association to change Good Friday to a half day of school to enable religious unit members to attend work and also participate in religious activities in the afternoon.

Discussion:

- Not possible to add hours to the day
- Three other districts have submitted waiver requests to Commissioner of Education
- For clarification purposes, 3/17 and 6/14 are already school day, no longer holidays
- Impact of school during April vacation for staff and families who have already planned and paid for vacations
- Reguest to move remaining half-day Wednesdays to the last week of June
- Developing a contingency in case more days need to be canceled

The School Committee recessed at 7:47 p.m. to convene in Executive Session for the purposes of strategy regarding collective bargaining.

The School Committee reconvened in open session at 8:34 p.m.

Mr. Sweeting announced that the School Committee just met in Executive Session and there are no votes to report. The 2014-2015 item is still on the floor.

After further explanation and recommendation by the Superintendent, the following motions were moved:

MOTION: Mr. Futrell made a motion, seconded by Ms. Rafal, to authorize the Superintendent of Schools to request a waiver from the Commissioner of Education for the three days lost due to the Governor's declaration of a State of Emergency and to send a letter to Commissioner Chester on their behalf.

The motion was approved via voice vote.

MOTION: Ms. Normand made a motion, seconded by Mr. Roix to declare Friday, April 3, 2015 as the 180th day of school as a half day.

The motion was approved via voice vote.

MOTION: Mr. Bockelman made a motion, seconded by Ms. Rafal, to authorize the Superintendent of Schools to enter into negotiations with the relevant unions to discuss the impact of April 3 including the loss of learning time and other issues regarding the school calendar, including the possibility of additional days closed.

The motion was approved via voice vote.

2015-2016

The School Committee discussed possible ways to reconfigure the calendar for 2015-16 which would not require collective bargaining. The Superintendent provided the following options:

- Make 9/1/15 a school day, instead of a Professional Development (PD) Day
- Make 9/4/15 a school day, rather than a day off for staff and students
- Change 10/9/15 from a PD Day to a school day
- Change 11/3/15 from a PD Day to a school day

Though the changes in these days do not need to be negotiated, the resulting scheduling of PD Days lost would need to be.

The following are possible changes that would require collective bargaining:

- Changing from three vacations (12/24/15-1/1-16, 2/15/16-2/19/15 and 4/18/16-4/22/16) to a December vacation and a March vacation
- Working on 3/25/15 (Good Friday)
- Starting school prior to September 1st

Discussion ensued and included:

- The fact that 9/4/15 does not need any bargaining, at all
- Looking at the possibility of March vacation beginning in the 2016-2017 school year
- The value of holding PD early in the year
- The reality that many districts are now starting the school year in late August

The decision was made to table further discussion of the 2015-2016 calendar until our next meeting on March 16.
