

Extracurricular Vaccine & Testing Policy (JLCB-B)

Somerville Public Schools | School Committee

Oct 18, 2021

Per Somerville School Committee Policy JLCB-B, all students ages 12 and older participating in athletics, intramurals, or other non-academic extracurricular activities must be fully vaccinated against COVID-19 by October 20, 2021, unless they apply for and receive either a medical or religious exemption.

Eligible students who have made good faith attempts to become fully vaccinated by receiving at least 1 dose of vaccine but who have not reached fully vaccination status by October 20, may continue to attend, practice or play.

Eligible students who have yet to become fully vaccinated by October 20, who have not received an exemption, or who do not complete the vaccine regimen at the specific interval for their vaccine will not be allowed to attend, play or practice after October 20.

Verification & Eligibility

• The COVID-19 vaccine status of students in athletics, intramurals, or other non-academic extracurricular will be verified by coaches or school health staff through the Massachusetts Immunization Information System, as is done currently with other immunizations.

Exemptions

- All eligible students must have documented vaccination status or apply for a medical/religious exemption. Exemptions are not guaranteed.
- The district has a form that students can use to apply for an exemption.

Routine COVID Testing

• All students in athletics, intramurals, and other non-academic extracurricular activities who wish to continue participating in those activities <u>must participate</u> in the district's weekly COVID testing at their school, unless they have applied for and received a medical exemption.



Students who opt out of the weekly COVID testing will:

- NOT be able to participate in non-academic extracurricular activities including athletics, intramural sports, and non-academic clubs as of October 20, 2021;
- NOT be eligible to participate in the Test and Stay program should they be identified as a close contact; they would need to quarantine for the required time and not be able to attend school during the quarantine period; and
- NOT have access to the district's free, rapid COVID-19 testing should their student become symptomatic while at school.
