# Currently offering Voluntary Limited Indoor Programming for Students with Highest Special Education Needs

- Continuing voluntary limited in-person support
- Moved from outdoor tented areas to indoor spaces starting February 1st at students' home schools: Kennedy, Capuano, and Winter Hill
- 2 hour blocks
- Baseline and ongoing COVID-19 testing for students and staff
- Mandated masks for both staff and students
- Deemed safe to move indoors due to limited number of students and staff and limited hours
- Available to approximately 18 highest needs self-contained classrooms
- 12 classrooms currently participating

# Safe Indoor/Outdoor After School (Community Schools)

#### SAFETY

- Deemed safe given limited time inside (1-2 hours) and limited number of students indoors at one time
- Takes place in large, open indoor spaces
- Students & staff required to follow all other health and safety protocols and to test weekly for Covid-19
- Afterschool staff have been working directly with students without known exposure or transmission since July, have expressed support for pilot, and have been participating in weekly COVID-19 testing

#### PLANS AS WE TRANSITION TO IN-PERSON LEARNING

- Continue program for students at Argenziano,
   Capuano, ESCS, Winter Hill, Healey, Brown, WSNS,
   and Kennedy
- Working with DPW to coordinate setup of outdoor tents in mid-March as weather permits
- Once in person learning begins for PK/K, the cohort schedule will be reversed to coincide and provide continuity of in person care.
  - Cohort A will switch to Monday/Tuesday
  - Cohort B will switch to Thursday/Friday
  - Afterschool staff may be available to support students with afternoon remote learning

# Transition to In-Person Learning: Health & Safety Protocols



The Somerville Public Schools and the City of Somerville have instituted a comprehensive set of health and safety measures to minimize risks for all students and adults in schools.



#### DAILY HEALTH SCREENING

All students and adults screen for symptoms of illness every morning and stay home from school when sick.



#### **FACE COVERING**

Masks covering the mouth and nose are required at all times in schools and on buses, except during scheduled mask breaks and when eating or drinking.



#### PHYSICAL DISTANCING

All school spaces will be set up to enable 6 feet of physical distancing, and students and staff will utilize outdoor space wherever possible.



#### HAND WASHING

Everyone in school washes their hands thoroughly with soap or sanitizer throughout the day.



#### **COVID-19 TESTING**

All students and staff receive a baseline test for coronavirus and are tested regularly to identify and isolate any positive cases.



#### AIR QUALITY

Prior to reopening, school buildings will have been upgraded with investments to improve ventilation and filtration, including centralized MERV-13 filters, portable HEPA filters, and Carbon Dioxide monitors.



#### PUBLIC HEALTH METRICS

The City and school district monitor transmission rates and other public health data to ensure it is safe to continue the transition to in-person learning.

# How is the district getting ready for In-person Return?

- Working with DPW to move furniture, specialized items, PPE, and teacher materials across buildings.
- Established teacher schedule to pack and move their classrooms and will also unpack in new location; teachers remaining in the same classroom will have time provided for set up.
- Contacting families regarding intent to return for Phases 2a, 2b and 3a in process.
- Working with unions and staff to determine accommodations, leaves, and remote assignments.
- Baseline testing of students and staff week prior to returning to in-person and according to a return schedule projected to take place this week.
- All subsequent phases will follow a similar pattern.

# Will my child have the same educator?

Somerville Public Schools will make every effort to have your child stay with their current educator. Their current educator may be in person or remote depending on the educator's circumstances.

There may be various reasons as to why your child's educator may not be able to teach your child in person and we will accommodate those needs. In the case where your child's educator cannot teach in person, we will do everything possible to allow them to teach your child's class remotely. There may be some extenuating circumstances which will not allow us to do that and in those cases we will have to accommodate the educator by providing them with a leave of absence. The leave of absences that will be granted to educators will allow them to come back to their position for the next school year and in some cases this school year. Educators will be protected under the Family Medical Leave Act (FMLA), American with Disabilities Act and the Family First Coronavirus Response Act (FFCRA) which we extended to the end of the school year.

Please know that we will do everything possible to make your child's experience a very positive one.

# What does the High Priority Phase 2a and 2b Learning Model look like for my child?

- Students in person M, T, Th, F
- All students learn remotely (both synchronous and asynchronous) on Wednesdays.
- Phase 2a students in high special education needs programs starting in-person learning on
   March 4th will attend for half days until March 14th or until the return of students in Phase 2b
- Half-day schedule for Phase 2a students will be:
  - K-12 8:10am noon, grab and go lunch
  - O PK 8:30am 11:30am, grab and go lunch
- Phase 2b Multilingual (ML) in SEI 1 Program and other special education self contained programs starting March 18 will attend full day
- Transportation
  - Special Education students who have transportation on their IEP will be accommodated with transportation
  - Multilingual learner students will receive bus transportation to SEI 1 programs if they are outside of their home school

# What does PreK-8 Hybrid Learning look like for my child?

- The PK-8 student population will be divided into two cohorts: Cohort A and Cohort B.
- Classes within each cohort will include 10-12 students.
- Students will rotate between a two day in-person and three day remote schedule.
- All students learn remotely (both synchronous and asynchronous) on Wednesdays.
- To accomodate balanced, equitable, classrooms, some cohort assignments may change. You will be contacted by the school Principal at least a week prior to your child's anticipated return.
- Students whose families choose to remain remote upon in-person return will continue to be taught by SPS teachers in remote assignments - grade and content appropriate.
- The district is actively negotiating with SEU on the teaching and learning and schedule components of the hybrid. There are 2 sessions schedule for this week. We will update families over the next 2 weeks.

# What does PreK-8 Hybrid Learning look like for my child?

- Maximizing in-person time for in-person activities to address social emotional learning and community building.
- In-person students will have both whole-class and small group instruction with appropriate distancing
- In-person PreK & K students will have both structured and unstructured play opportunities
- Students in both cohorts will be given in-person ELA and Math assessments to identify academic strengths and areas of growth
- Maximizing synchronous (live) instruction for students during remote learning days
- Prioritizing continuity during remote days so all students feel connected to their class. Examples of this are Morning Meeting and Closing Circle
- Specialists will remain remote and all students will participate in class together

# What does Special Education programming and services look like for my child?

- Self Contained programming will be 4 days per week. (M, T, Th, F) Wednesdays will continue to be all remote with synchronous and asynchronous instruction.
- Students in general education settings will return with their grade levels and follow hybrid learning.
- Related Service (OT, PT, Speech and Language, Resource Room/Inclusion, etc.) in-person services will begin on a limited basis as each program/grade level returns. In-person services will be determined using data collected regarding students ability to access remote learning/therapy. Many students will continue to receive services remotely on remote learning days.
- Students who have returned with their program/grade level will access inclusion opportunities remotely in alignment with DESE guidelines.
- Data collection will be ongoing regarding progress towards goals and objectives and used to inform instruction and services.
- Staff will be reaching out to families to update Special Education Covid-19 Learning Plans for any remote day services.

# What does Multilingual Learner programming and services look like for my child?

#### If my child is enrolled in SEI 1 grades K - 8:

- Return to school 4 days per week (M, T, Th, F) in phase 2b.
- Wednesdays will remain remote with synchronous and asynchronous learning
- ESL Learning: Practice Listening, Speaking, Reading, and Writing in English
- Specialized language supports to learn content (Math, Science, Social Studies)

### If my child is enrolled in SEI Integrated class or receives ESL Services:

- Return to school in Hybrid Model with grade level peers
- Receive ESL supports in remote lessons to support language development and content learning

#### If my child is enrolled in Unidos:

Return to school in Hybrid Model with grade level peers to continue Dual Language learning

### If my student is of high school age and enrolled at SHS:

- Priority students will be invited to Multilingual Learner Labs 4 days per week (M, T, Th, F) in phase 2b
- 8:10am 12:00pm with grab and go lunch; learning will continue online in afternoon
- Tutors will support Multilingual Learners to participate in online ESL and Content classes
- Multilingual Learners at Levels 1 and 2 will return to in person ESL when feasible

<sup>\*</sup> For all Multilingual Learners: ongoing common assessment, progress monitoring, and on-site ACCESS

# **An In-Person Day in the Life of Our Students**

Greeted each morning by members of the child's home school.

Escorted from caregivers safely to class.

Breakfast and morning meeting daily.

Robust social emotional learning experiences.

Robust academic learning experience.

Opportunities for play indoors and outside.

Escorted from school personnel to designated caregiver at the close of school.









### What about breakfast and lunch?

### During Phase 2A and 2B:

- For students who are still in remote learning, we will continue to operate all current locations and times of our Grab-and-Go meal sites
- For students who are returning to school buildings, we will deliver shelf stable breakfast and lunches to the students in their classrooms.
- Meals will be delivered in insulated bags that will ensure all health and safety guidelines are being followed.
- Accommodations for nut-free space or other allergy considerations will be arranged

As phases continue and more students return to school buildings, we will develop a plan that ensures all students have access to meals both in the building and through our Grab-and-Go meal sites.

# **COVID-19 Testing**

Barring an approved medical exemption, COVID-19 baseline and routine screen testing will be required for all students and staff returning to in-person instruction.

#### What is a baseline test?

Part of the assurance testing program, a baseline test is the first test provided to each new group of students and staff returning for in-person learning. The goals of baseline testing are to ensure that everyone returning is COVID-19 negative, and to capture all the registration information necessary prior to ongoing assurance testing.

### **Routine COVID-19 Testing**

- Baseline and routine testing weekly
- Baseline tests will take place the week before in-person learning begins
- Weekly testing will take place in child's school
- Families will be notified of any positive test results
- Successful piloting with staff and students
- If concerns about your child's ability to participate in COVID-19 testing, please consult with your child's school Principal and nurse.

# SPS COVID-19 Testing: Not Using "Brain Tickle"

### **Anterior Nasal Swab**

- Minimally invasive
- Anterior nostrils (lower part) gently swabbed in circular motion
- Students may be able to self-administer test, trained health staff will help students as needed
- Preferred testing method for students and staff




# My student shows symptoms of COVID-19 at school. Now what?





1



Students with COVID-19 symptoms will be sent to the school nurse for a health evaluation

2



The nurse will determine whether your student needs to be sent home to isolate, or may return to class

If your student shows signs of having COVID-19, the school nurse will call you, detail symptoms, and request that the student be picked up from school





Please plan to pick up your student within 30 minutes of being contacted by the school nurse





Call your child's primary care physician and isolate at home except to seek medical attention





Get your child tested for COVID-19 and report results to school nurse

# Important Information to keep your child healthy

- Provide updated medical and vaccination records to school nurse
- Provide signed copy of <u>Attestation Form</u>
- Keep your child home if he/she is showing any symptoms or sick
- Participate in Baseline testing week prior to start of school for your student
- Participate in weekly COVID-19 testing for your child
- Update emergency contact information, important to have someone available to pick up your child if needed within 30 minutes
- Prepare your child for wearing masks
- Communicate any questions or concerns to your child's teacher, school principal, or school family liaison
- Remain positive and support your child in the transition back to school. Reassure your child that we are working together to keep everyone safe! :)

#### SPS Student DAILY symptom screening

SIGNING THIS FORM ONCE INDICATES THAT YOU WILL PERFORM DAILY CHECKS ON YOUR CHILD

Prior to school every day, each student and staff member must self-screen using this checklist:

- 1. Does your child have any of the following symptoms that are not related to a chronic condition?
  - □ Fever (100.0 or greater)
  - □ Chills or shaking chills
  - New cough (not due to other known cause)
  - Shortness of breath or difficulty breathing
  - Unexplained fatigue (when in combination with other symptoms)
  - Muscle or body aches
  - □ Headache (when in combination with other symptoms)
  - □ New loss of taste or smell
  - Sore throat
  - Congestion or runny nose (not due to other known causes, such as allergies) when in combination with other symptoms
  - Nausea or vomiting or diarrhea

\*If a child has any of these symptoms, they should stay home, stay away from other people, and you should call their health care provider. Do not send your child to school if the child has taken medication in the past 24 hours to lower temperature (for example Tylenol or ibuprofen.

- 2. Has your child had close contact (within 6 feet for at least 15 minutes) in the last 14 days with someone diagnosed with COVID-19 or tested positive for COVID-19, or has any health department or health care provider been in contact with you and advised you to quarantine your child?
- 3. Have you traveled to one of the states currently listed under the <u>Massachusetts travel restriction</u> that requires an automatic quarantine/COVID testing?
