### WHAT IS CTE

- CTE stands for Career Technical Education
- In the state of Massachusetts, most CTE programs are considered Chapter 74 Programing
- Chapter 74 Programs have strict guidelines and oversight from DESE
- The 17- 6 day rotation exploratory program is approved by DESE and will run until the end of May



### CHAPTER 74 PROGRAMS

Currently we have 14 Chapter 74 programs

\* Advanced Manufacturing \* Architectural Design (Drafting) \* Automotive Technology

- \* Carpentry \* Cosmetology \* Culinary Arts \* Dental Assisting \* Early Education
- \* Electrical \* Graphic Communications \* Health Careers \* Plumbing \* Metal Fabrication
- \* Heating Ventilation Air Conditioning & Refrigeration (Approved this year)

All students have the opportunity to earn industry recognized credentials in these programs



### CENTER FOR CAREER TECHNICAL EDUCATION ENROLLMENT

#### • Total Enrollment for 2021/2022 school year- 634

- Including 251 Exploratory students (9th grade)
- Total Enrollment for 2022/2023 School Year- 687
  - Including 259 Exploratory students (9th grade)
- Total Enrollment for 2023/2024 School Year- 798
  - Including 296 Exploratory students (9th grade)

### **INCREASING ACCESS TO CTE**

#### School Year 2022-23

- Changed the CTE schedule from 5 different schedules to 1 uniform schedule to increase opportunities for academic class scheduling (Increased access to special education and MLE students to meet state required classes)
- Added a 4th block to the senior year to meet the 900 hour requirements

#### School Year 2023-24

- Possible waiver for English Learners or Former English Learners up to 5 credits that can be applied to courses not required by state or federal regulations
- Hired a multilingual paraprofessional to support the increased enrollment of MLE students
- Added 2 new rotations in exploratory- Career Exploration and College and Career
- Opened enrollment to Full Circle students

School Year 2024-25

Change in Requirement for grade 11 and 12 CTE programs and PE/Health

Wellness Program - Embedded Health/PE rotation junior & senior year of CTE in lieu of a PE/Health class

<u>Change in Requirement for Health Careers 3 and Dental Assistant 3</u>

Human Physiology- Embedded into Health Careers and Dental Assisting- Increase opportunities for students to take additional classes (AP, World Language, Electives, etc)



### **INCREASING ACCESS TO CTE**

School Year 2024-25

 <u>Change in Requirement for Architectural Design / Pre-Engineering 3 and</u> <u>Advanced Manufacturing 3</u>

Steam Design & Engineering 1 and 2 - Embedded into Drafting & Advanced Manufacturing fulfilling 5 of the 15 science credits




### PROGRAM LAYOUT IMPROVEMENTS

- Created 31 booths for students to work on individual projects
- Creates a real world residential application with construction framing
- Upper portion of the booths have plywood for different applications for senior group
- The booths open up the line of sight for staff to see the students throughout the shop
- Layout allows for more storage for supplies/materials



### PROGRAM LAYOUT IMPROVEMENTS

- Program was set up with 24 small cubicles/desks that was industry standard
- Reorganized equipment and built benches to mimic a HVAC-R / sheet metal shop
- Purchased additional equipment and freshmen tooling to accommodate 20 students in the exploratory program



### Skills USA

- Last year was the first year we had 100% participation in Skills USA
- 75 Students competed at the District Level
- 12 Students went onto the State Competition (4 gold, 4 silver, 4 bronze)








# COMMUNITY PARTNERSHIPS






### COOPERATIVE EDUCATION


- The Cooperative Education Program is a continuation of the CTE program that provides qualified juniors/ seniors with an employment opportunity in an industry setting

- At minimum quarterly site visits are complete by Cooperative Education Licensed person (Meg McDevitt)














### POST GRADUATE PLANS

37% of college students plans/majors are related to CTE program






### POST GRADUATE PLANS

# CTE CHALLENGES

- Enough equipment/space for future student enrollment
- Funding for enrolled students (Enrollment has increased by 26% past 2 years / zero increase in budget) \$125,000
- Perkins Grant (25% is the new Multilingual Para position)
- Funding for equipments maintenance/repairs (Currently coming out of the \$125,000)
- Staffing as enrollment grows / vacancies
