# IV. REPORT OF SUPERINTENDENT

## A. District Report

Dr. Carmona started his report with an opening remark that read as follows:

### **Opening Remarks**

Good evening. I feel honored and privileged to be part of this wonderful community.

In the short time that I have been here, one of the things that has become clear to me is that this is a community truly invested in our schools and in our students.

I want to start tonight's meeting with a little bit of information about who I am and what drives me in this work. My journey in education took root in the public school system. I served as a Principal in Lowell and Salem for a total of 11 years and as a Principal Coach in Boston before joining the Salem Public Schools as a Principal and Executive Director of Family, Community, and Employee Engagement. The insights and experiences garnered through these experiences have profoundly shaped my educational philosophy.

One of my core beliefs, shaped by these experiences, is the indispensable role of family engagement in building community and shaping our children's education. By working together and understanding the unique needs and strengths of our students, we can provide a learning environment where each student feels valued, understood, and supported.

As Superintendent, my priority will be to ensure that every student, regardless of their background or circumstances,

has equitable access to a quality education. We are privileged to serve a wonderfully diverse community of learners, and we owe it to each of them to create a learning environment that inspires curiosity, instills resilience, and fosters a lifelong love of learning.

With the start of the new school year just two days away, I have already witnessed the tenacity, commitment, and community spirit across the district. During these first two months in this role, I have been able to visit every school, witness programs and planning in action and meet with students, educators, and administrators. I am deeply grateful for the opportunity to work with such an incredible community.

Yet while these few months have been full of hope and incredible planning on everyone's part, it has not been without challenges along the way.

I know that for the past several years, the district has undergone a lot of periods of transition. First, like most communities nationwide, you focused on a transition back to full time, in person learning following the pandemic. Over the last year you have transitioned between superintendents and a reorganization of the administrative team. Most recently, we as a district and a city have been addressing challenges in our physical infrastructure, particularly at the Winter Hill and Edgerly.

In the last two months we had to unexpectedly close the Winter Hill School, shifting classes and operations to multiple locations. This has meant moving staff, educators, and students between multiple buildings, coordinating at many levels for construction and assessment at two buildings, and coordinating schedules for classes in new schools. Under the Mayor's leadership we have expedited assessments at the Winter Hill to help us better understand the next steps for that building, while also undergoing construction at Edgerly to enable us to welcome classes on time this week. We'll have more specific updates to share later in tonight's agenda.

I know that this has been a difficult and, at times, a frustrating transition. For all of us. Closing a school and shifting operations in this way is absolutely never an option we want to create. However, for all of us, the safety and well being of our students and our staff is our top priority. For our Winter Hill students and staff who are starting this new school year in new and different spaces: we are ready to welcome you with open arms on Wednesday.

As of my most recent visit to the Edgerly Building this afternoon, I am happy to report that construction activity is wrapping up as expected and that we are on target to have classrooms ready for the first day of school. There are some final touches and cleaning that will occur over the next 24 hours, and we will prepare to welcome families and students to the building tomorrow evening for brief tours. As with any construction project, there will also be some minor "punch list" items that will likely need to be taken care of over the next several days during non-school hours.

Throughout this process, our goal has always been to put transparency at the forefront. However, along the way we know that there have been opportunities for us to do better, and I want to reaffirm my commitment to you that for me, transparency and family engagement is critical.

I am confident that our commitment, focus and systems will bring about a period of equitable change, academic improvement, and joy and engagement for all of us.

The Committee recessed at 7:21p.m. to acknowledge and celebrate new administrators, and returned at 7:29 p.m.

• WHCIS and Edgerly Facilities Updates

Dr. Carmona started the WHCIS update with some details for families but he first wanted to reiterate gratitude for the collaborative spirit between staff and stakeholders. He thanked Tuft University for their support for our staff and students and also offered heartfelt thanks and appreciation to the Winter Hill staff for once again navigating building moves.

There has been tremendous work done in the Edgerly inside and outside since mid-July. Thank you to Suffolk Construction who has been working extended hours including weekends to have the Edgerly ready for our students to start school on Wednesday August 30, 2023. Just wanted to be clear that even though work was done in an expedited timeline, we in no way sacrificed quality for expediency. The teams are qualified and skilled and have done incredible work over the last few weeks.

- Winter Hill Community School will now be physically located in two buildings -- at the Capuano and Edgerly. Principal Gosselin and her team are working hard to make sure all students feel like they part of the Wildcat Family.
- > WHCIS Administration and Specialists will provide support at both buildings.
- > The Edgerly exterior has been repaved and converted to a large open play space with murals.
- > Working with ESCS for access to their outdoor play areas for students at Edgerly.
- Transportation –as of last week, we have secured transportation from and to 115 Sycamore St. Due to limited number of seats, students will be selected based on eligibility beginning on Friday. Our goal is to accommodate as many students as possible but addressing family needs is the most critical component as of now.

Mayor Ballantyne -- Welcomed Dr. Carmona as the new SPS Superintendent and expressed appreciation for the partnership and collaboration that has been brought to the district from day one. Acknowledged that the last couple of months have not been easy for families and students at Winter Hill. Also noted that she was excited to share that school for Winter Hill students and staff will begin on Wednesday August 30, 2023, at their new location. Noted that our teams are working on completing final tasks to ensure we are ready to welcome students. In nine weeks, we were able to mobilize city resources to move 430 students and staff to two new buildings. Noted that an incident command structure comprised of a team of 30 people was activated to oversee and support planning and implementation efforts for the Winter Hill's move to their new temporary sites, including food service, transportation, mobility, recreation and after school programing. Mayor Ballantyne also noted that work on the K-8 Master Planning has continued as we have been working on moving students to their temporary spaces, and assessing the WHCIS at the Sycamore building. In spite of our need to close 115 Sycamore to deal with the remediation, we have continued to make progress. SPS and Capital Project teams have completed a detailed review of the district-wide enrollment study, performed an in-depth evaluation of special education and enrollment trends, which will help us to forecast needs district-wide and at the WHCIS. Engineers and architects have completed their broader structural evaluation of the Winter Hill building. Are currently using data to provide conceptual designs for a range of options of renovations, additions, or total reconstruction of the Sycamore Street side. They are in the process of preparing these reports for our review. Expect to see those results in September. This is all the baseline information from which we will select a design team, establish a school building committee, and then continue into what the MSBA calls the feasibility study. We are on track to move to these next phases this fall. We are committed to engaging our school families and community in discussions to help guide our decisions. Our community will be helping to shape the future of our schools that serve them.

Mr. Rich Raiche - Shared information about 115 Sycamore St. and indicated that we do not have a final report but do have results back on the second round of testing. The initial round revealed asbestos in concrete in stairwells, that we were not expecting. On Monday, August 7, we closed the WH school out of an abundance of caution. After the building was closed, consultant reentered the school and did additional testing throughout the school. The reason we

had the concern is that we had a structural consultant as well. The act of that testing on that material raised concerns. We reentered the building on August 10<sup>th</sup> and did 3 types of sampling: air sampling all came back negative - all within normal air quality standards; swab samples of dust throughout the building all came back negative as well. If there had been a release of asbestos and if it had settled out, it would be present in the dust. All of those dust samples came back negative. There is no evidence that the testing created a release. All of those tests are by professionals in the field certified by OSHA and EPA and DEP. We filed for an emergency waiver from the state DEP to immediately go in and abate those areas there were disturbed. We received that and we have been working on that abatement in those stairwells ever since. The other good piece of news out of the secondary testing are bulk samples. We went in and did additional bulk sample testing and it's not all the concrete throughout the entire building. It is specific to the stairwells and some columns. The same company that did that testing is accompanying the abatement contractor and verifying that their abatement work is in fact taking care of any of the disturbed areas and encapsulating the material. Will have a full and final report once all this work is done.

### **Questions/Comments**

Acting Chair Krepchin - You talked about the report and there being exciting news. How are you planning on sharing it with the community? Mr. Raiche - As of now what we have is raw data. When we get to the end of the remediation, we will have more of a narrative that is digestible.

Mr. Green - Can you give a vague timeline for when the end of the remediation will be and the building may be available? Mr. Raiche - Contractors anticipate about 2 more weeks of work.

Ms. Pitone - Abatement work is in progress and then the intention is to continue to do this evaluation in terms of whether to continue to use this space, renovate this space, but we have to renovate first, is that correct? Mr. Raiche – Yes, that is correct.

Dr. Phillips- We got this great encouraging letter from the MSBA. Where are we in the process of getting the onsite meeting, the tour? Mr. Raiche - Jackie Piques and I had a good meeting with them on Friday. Tentatively scheduling the next step – what they call the senior study – in late September.

Ms. Pitone – It was very encouraging to see the letter saying that they are moving forward at least to the next step. So, implying from this that we did not receive something like this about the Brown. Mr. Raiche – At our meeting on Friday, they have not formally advanced the Brown to what is called a senior study, however, we are tacking on a site visit to the Brown after the Winter Hill visit.

Mr. Green - Historically each municipality is allowed one building at a time. Have you had conversations with MSBA about both buildings being funded? Mr. Raiche – Generally, it's true that no community has had more than one school funded, with the exception of Boston. They are a very large district.

Ms. Pitone - At what point would a timeline for the K-8 Master Plan work be shared. Mr. Raiche - Wouldn't anticipate having a full final report with graphics until the end of September.

Ms. Pitone - Trying to understand; we have two buildings with challenges but this Master Plan work is across the district. I recognize these things will be related but from my perspective it seems that they are two different projects. Dr. Carmona - It is hard to separate Winter Hill and the Brown School as separate units. There is not a solution that fixes one or the other without responding to the needs of the entire district.

Mr. Green - You said some of this is a trigger for staff right now. As for the to-do list, from the perspective of someone studying or working in school, what will you see as incomplete? Mr. Raiche - Most are internal and are not very noticeable. The handrails on the new concrete steps at the main entrance are temporary because they need to be measured and fabricated. We will place final handrails.

Dr. Phillips – Anything else about envelope or structural issues that we haven't said yet but still need to be addressed?

Mr. Raiche – Roof – not something that we can do occupied. Will also need to do some upgrades to electrical systems. Again, not something we can do while it's occupied; perhaps summer or winter break to start chipping away

at that. What was known as the Boxing Club is still not integrated. There is work that, if Winter Hill stays there for a longer duration, we may want to activate that space for other uses. Not a publicly accessed area right now.

Mr. Green - directed his question to Dr. Carmona: To do all this work, we have had to move a lot of people. Have we publicly communicated to the school community where people can be found in the district? Where is the x and y office that used to be located in Edgerly? How do we let people know that? Dr. Carmona - Everyone was moved to the TAB. There might be some SFLC groups also creating other spaces, but everyone is in the TAB. How are we communicating that?

Mayor Ballantyne added that emails are the same and the telephones have been routed. It's just the physical location. I assume that possibly in the next newsletter would be a great start for notifications.

Jackie Piques - There are several ways. District newsletter will start next week. Direct emails and potentially phone calls, but it is planned with the start of school to let everyone know.

Mr. Mazza – Shared that as we started this transition, there were several front-facing departments that needed to continue operating without disruptions. Departments have been communicating where they were temporarily located and where they were moving to. The Enrollment Office moved to the East Somerville Community School temporarily (as did Finance and Payroll), but are now at the TAB. Same with SFLC.

Mr. Green – As a follow-up, I know we have paid high rent for space in the TAB. Is Tufts doing us a solid? Mr. Raiche – The additional rent is only for the new spaces where SPS moved in. The areas where we were already occupied, the terms of the previous agreement still stand. Will be bringing to City Council next week as the Tufts agreement is finalized.

Ms. Pitone – Acknowledged flexibility of staff in centering our students and staff, despite the disruptions to their work environment.

Acting Chair Krepchin – Recommended that someone videotape the Open House tours and post video online for families who may not be able to attend.

Mr. Green – Once Edgerly fully up to speed, there will be things that we did not foresee. Asking for report at next meeting for report of how building is going once it's in full use.

Class Rank Update

Dr. Carmona - This is a more instructional focus. Salem High School leadership has also been working on this over past 2 years. He is coming new into this and part of the question has been to bring this to the School Committee, to share the proposal. Basically, supporting our goals around the whole child, equity, and college and career readiness. The Class Rank process creates a lot of perceptions around deficit especially around groups of population who don't have access to the class rank process, like our MLs and students receiving special education services, and students who are in the CTE track. There are different reasons why this concept about class rank also has connotations that are limiting for most of our populations. 100% of the counselors in the school support this idea of eliminating the class rank. Research the team has done around colleges and with schools in our vicinity that don't use class rank. SHS leadership felt strongly about this proposal. High School principal Alicia Kersten is here to address any questions regarding the proposal.

# **Questions/Comments**

Acting Chair Krepchin - This has been before Ed Programs but has not been before full School Committee. Is this something we will be expected to vote on, or more informational? Dr. Phillips - Decision last year was that this does not require a full School Committee vote, they just want to make us aware.

Principal Kersten - In doing the research – and huge shout-out to our Director of College and Career Readiness, Ms. Kessler for leading this work -- we found everybody strongly in favor of eliminating class rank, but more research to

be done around the weighted grades. Related, but we are seeing them as two separate things.

Mayor Ballantyne - I haven't read this package, but what I don't understand is how it works in the outside world. Is class rank determined when you apply to college? Principal Kersten – Part of the process that Ms. Kessler did was interviewing 19 colleges, and all of them said that it wouldn't impact. They know that some schools no longer calculate. It should not impact a student's chance to get into a college or not because they know that the school does not calculate class rank. Several schools around us do not classify, including Cambridge Rindge and Latin, for similar reasons to the reasons we want to.

Chair Krepchin - Do the schools that have stopped seen a negative impact? Principal Kersten - I don't know that.

Dr. Phillips - Can you speak to how class rank negatively impacts Special Education and ELL students? Principal Kersten – Great case study in the slides. Because ELL students must take double blocks of ELL, they will never be able to reach the top even if all their other classes are AP, because ELL classes are not weighted equally.

Ms. Pitone – Thank Principal Kersten and state that this has been a conversation for years, since before the new high school building. I'm excited and I want to clarify if people who are watching don't know, this wouldn't happen until our current 10th graders are seniors.

Principal Kersten - We were hoping it would be with this year's juniors, but it got delayed. We are still calculating class rank for juniors and seniors but we are manually setting sophomores to 0. By the time they are seniors we can just not have it reported instead of seeing a zero there.

Chair Krepchin: CTE students, the ranking is also not accurate or fair? Principal Kersten - Yes, I like how Dr. Carmona put it, it is an arbitrary measure of success and it's not fair.

Dr. Carmona: We talk about equity in these real moments. Learning a new language is not a deficit, it is a new skill and yet you are penalized. The other implication that is detrimental to Special Education is that there are also classes that develop basic skills and limit access to AP Calculus. And students respond to expectations: They take AP Calculus because it's what's expected, not because it's what they want to choose, like music, but the system tells them it's not a good option. This does not mean that we will lower academic rigor. When I talk to the HS principal, it is very personal to me. Supporting children is giving them the tools to access higher learning. Even if class rank is not part of what we use to determine academic rigor, we want to ensure that all children are career and college ready.

Ms. Barish – Grateful for slides and appreciate work gone into this. Look forward to hearing more about what would happen with weighted GPA. Also, there were a couple of slide saying, should there be a Valedictorian? Curious what other criteria could be used to choose to represent their class at graduation. Was thinking about the Highlander Habits. Having participated in the accreditation, was really impressed and wondered if that could be part of what helps decide what student would represent their class at graduation if in fact, a Valedictorian was no longer a thing. Looks forward to seeing where this goes and how this work can develop to better serve our students in the district.

Ms. Pitone – Curious – can you share a little bit about the thoughts or concerns around the weighted GPA. I know there's still some research to be done. Ms. Kersten – Part of the reason we tabled it is when Ms. Kessler was interviewing students, there was a strong feeling of this idea of when you're taking on more of a challenge, of deserving to get a little more. We haven't unpacked that and I think we need to do a lot more research, and we really wanted to value the voice of the students in our decision. It wasn't as clear among the student population that that was an easy one to get rid of right away. We're thinking through it and I think we need to do more investigation, more focus groups with students. The truth is that colleges do their own re-weighting of the classes on transcripts.

Chair Krepchin - Thank you for taking into consideration what students are saying. Looking forward to hearing more about this in the future.

• Community Schools Update

Mr. Mazza shared the community school update presentation linked below.

## **Questions/Comments**

Ms. Barish - In the past, there have been questions about whether we have enough SPACE for students, whether we can get the staff? Mr. Mazza - If we get the staff, we will find space. We have been talking to our principals. These are our students and we need to keep our doors open.

Dr. Phillips - We have heard reports from Community School staff that a barrier to hiring is the platform. Is there any talk about using a different platform, maybe the same one that the recreation department uses? Mr. Mazza - Yes, one problem is that when we send ads on Indeed and people say yes, they also have to apply on Talent Ed. So we are asking people to apply twice. So we seek to simplify. We ask them to do twice the amount of work to apply for one thing. Looking at that collectively as a whole.

Ms. Barish – One program already in place, El Sistema, has heard that people want their children to attend but they need to find a way to get there. Could the transportation situation be improved in any way? Mr. Mazza - If there is space, we should have children enroll. I know there's this thing about how certain children get transportation and others don't. If there is a space available on the MLE bus, they can take it. However, I don't know if we can even do that other than the MLE bus.

Ms. Barish asked for a more detailed answer on transportation. Mr. Mazza - We have three Multilingual Education buses that go to Argenziano, East, or Winter Hill. If a student at WH is in El Sistema, and there is an open seat on the bus, the school checks with the MLE Dept. and then that student can ride the bus. There is no specific bus for El Sistema, it is just a run that they are doing and a student may, if there is space and it's allowed, get on that bus.

Dr. Phillips: I'm getting a lot of emails about the Community Schools waitlist at Argenziano. Given our communication challenges in the past, what type of communication will be sent to families who are still on the waitlist at this time and when should they expect to hear back? Mr. Mazza - Argenziano is short four teachers, so 52 students. They have 29 on the waitlist. I will talk with Director Paribello to make sure there is a communication sent out before school starts, which would have to be tomorrow.

Chair Krepchin: Just to clarify, if we hire the 4 teachers at Argenziano, that would be more capacity than the current waitlist? Mr. Mazza - yes

Mr. Mazza added that he can come back at the end of September with another update. Maybe we can have a rolling monthly update for Community School to share how the hiring process is going.

Ms. Pitone - I appreciate the capacity increase, but I'd like to highlight a few important points. The team is aware of critical issues. Specifically, when we compare Argenziano, with 89 students, to Brown, a smaller school with 105 students, we need to ensure equitable access to programming. While I understand that this may require additional staff, it's crucial to address this concern. Insufficient staff leads to fewer applicants and doesn't accurately represent demand on the waiting list. This issue applies to Community Schools and associated programs as well. I want to bring this up because voters have raised it, and while I don't want to take away seats from Brown, we need to strive for more balanced ratios across our schools.

School Readiness

Mr. Mazza shared School Readiness buildings look fantastic. He raised the point that our schools are highly programmed during the summer, making it challenging to perform cleaning and maintenance tasks. However, thanks to our partnership with DPW, we have managed to ensure that all buildings are prepared for students by Wednesday August 30, 2023. If any issues arise, we have a 311 reporting system for immediate resolution, ensuring that classrooms are fully functional.

Dr. Carmona: Another aspect of readiness is focused on professional development. At Lynch Academy, principals returned a week early to kickstart this process, emphasizing the importance of centering instruction in everything we do and aligning with critical initiatives. We're also providing strong support for our 80 new teachers through a robust induction program. Last week, we held two sessions with all district leaders to discuss our instructional priorities

On the infrastructure front, the Mayor and I have discussed the importance of preventing situations like the Winter Hill or Edgerly incidents from happening in the future. We're examining our approach, aiming to be proactive, and ensuring the 311 process is clear. I've had the opportunity to visit buildings alongside Mike Bowler and Chad Mazza, and I'm highly impressed. Having worked in three districts, I've never seen this level of attention. It's clear that the leadership, including the Mayor, is fully committed to avoiding neglect and reactive measures with our beautiful buildings.

I want to express gratitude to the City and the Mayor for their proactive involvement in this matter. It's crucial that we closely monitor the 311 reports. From a systems perspective, I believe we've made great strides, considering the challenges posed by the pandemic.

Dr. Carmona shared the district report:

## Notes-Superintendent's Update: School Committee Mtg – Monday, August 28, 2023

I am excited to start the 2023-2024 school year in Somerville Public Schools. I am grateful for the incredible school and central office staff who have welcomed me aboard. Somerville is a vibrant and engaged community that supports schools and I look forward to a year of working closely with the school committee, staff, teachers, families, and the community.

### Winter Hill Community Innovation School Transitions

The effort to transition the Winter Hill students, as well as Central Administrative staff, to new facilities has been an on-going and intense collaboration between city and schools. We meet regularly with our partners from other City departments —

particularly DPW, Infrastructure and Asset Management, Capital Projects, Inspectional Services, Mobility, and Communications and Community Engagement. Central office and Winter Hill leadership have worked tirelessly this summer to provide the best outcomes for Winter Hill students and staff, and to stay in close communication with the community. # Yearly Student Information Updates

Families are encouraged to look out for an email from the Enrollment Office through our Powerschool online registration portal. Every fall, we ask that families update vital information about each of their students, including allergy and medical information, family contact details, and a list of people authorized to pick up students in grades 4 and under. Filling out the form may also allow families to qualify for benefits, like fee waivers and other services. This process takes around 15 minutes for each student. Thank you to the Enrollment Office team and our IT department for their work on Yearly Student Information Updates. A particular shout-out to Enrollment Specialist Nancy Holmes for her hard work collaborating with our vendor, our internal technology staff, and administrative staff to prepare this process.

### **Summer Programming**

Somerville Public Schools had another successful year of free summer programming, meeting the out-of-school time needs of almost 1200 students. Coordinators Dayshawn Simmons and Mary Ann Cloutier created a single-point-ofentry application for all SPS summer programs that was shared on the SPS website and through student- and familyfacing staff with parents and guardians. Programming included traditional summer school that kept students at gradelevel, but most of our programming was enrichment programming. These engaging and educational programs included The Calculus Project, student-developed robotics programming for middle grades and English language learners, music programming for 3rd - 8th graders, orientation to Somerville High School for rising 9th graders, middle grades career and technical education programming and more. Thank you to Dayshawn and Maryann for their hard work and a big shout-out to the educators, staff (including administrators and nurses) who worked so hard to make this summer a success for so many of our students.

### **NEASC** Accreditation

Somerville High School continues to work toward renewing their formal accreditation by the New England Association of Schools and Colleges. SHS staff worked through an intensive Self-Reflection period, hosted an assessment

conducted by a visiting team of professional educators. The team reviewed materials prepared by the faculty, visited classes, and spoke with students, teachers, administrators, parents, and community members. The Self-Reflection document written by SHS staff will be available for viewing soon on the SPS website. The assessment team of educators from NEASC will return in 2025 to observe how their recommendations have been adapted across the school. Thank you to Principal Kersten and Lisa Brewster-Cook for managing this important process.

### **Upcoming Half Days and School Holidays**

Students in grades 1-12 start school with a half-day on Wednesday, August 30. Thursday, August 31st is a full day for students in grades 1-12. All SPS schools will be closed on Friday, September 1; district offices will be open that day. All schools and district offices will be closed on Monday, September 4 in honor of Labor Day. Tuesday, September 5 is the first day of the school year for students starting prekindergarten and kindergarten. Prekindergarten students will end their school day early for their first 4 days of school. September 13 will be a half-day for all district students.

### Shout Out

Shout out to the 2023 graduates of the dual enrollment program between Somerville High School and Cambridge College. They are Julissa C., Javory Clergeau, Marco De Toledo, Jaslene Jean Francois, Anders Haugesag, Kayala Nayak, Shital Oli, and Laura Garcia Yanes.

Since 2019, students at Somerville High School have enrolled at Cambridge College as juniors and seniors to earn up to 12 free college credits that they carry with them to college. The Early College program is designed to promote access to higher education among students from traditionally marginalized backgrounds. Twice a week, students are transported to Cambridge College, in Charlestown, for classes like Engineering, World History, and Digital Storytelling. In addition to our 8 graduates, 19 juniors took part in the program last year.

Thank you to Director of College & Career Readiness, Melanie Kessler and other members of the Somerville High School team for developing and expanding this program. Learn more about this program and our recent graduates on our website.

In order to address the root causes of systemic inequity in our schools, the Somerville School Committee and SPS commit to the following goals, knowing that these can only be achieved through ensuring meaningful partnerships with Somerville families, district staff, city government, and community partners. Our goals attempt to address deep-rooted systemic barriers that have prevented us from achieving our district vision of equity and excellence and ensure that all students, regardless of race or ethnicity, have the supports and resources they need to achieve educational success in our district now and in the future.

1. Whole Child Teaching and Learning... we will:

- prepare students to demonstrate strong literacy and mathematics foundation by grade 3, grade 6, and grade 10
- provide all students with integrated classroom lessons from a high quality social-emotional learning curriculum that helps students value and develop their ability to build relationships with other students, to be self aware and socially aware, to self regulate, and to make responsible decisions
